# Minutes of the Board of Education – Regular Meeting

September 18, 2017 – 7:00 p.m.

Call to Order, Pledge, and Roll Call: The Pontiac Township High School District No. 90 Board of Education held its regular meeting in Dr Ronald J Yates Memorial Library on Monday, September 18, 2017. President Roger Corrigan called the Meeting to order at 7:02 p.m.; the Pledge of Allegiance was recited. Board members Mrs. Brainard, Mrs. Murphy, Mr. Sartoris, Mr. Clemmer, Mr. Lambert, Mr. Schrock and Mr. Corrigan answered roll call. Also present were Administrators Jon Kilgore, Eric Bohm, Tera Graves, and Board Secretary Kelly Carter.

**Budget Hearing**: A motion was made to suspend the regular school board meeting and move into the PTHS and LACC FY18 budget hearing:

Presentation of the FY 18 Budgets, Revenues and Expenditures for PTHS District 90 and the Livingston Area Career Center: Mr. Kilgore presented a balanced budget with a surplus in the Education Fund.

Discussion of the Budgets: Mr Kilgore explained the new evidence based funding for Senate Bill1947 and the this will be a new formula for state funding with some changes to mandated categorical payments.
